## **BACKGROUND**

The Kansas State Rifle Association Foundation was created in early 2000 as a 501(c)(3) entity for the purpose of raising funds to support legal sport shooting programs of all kinds in Kansas. At this time these activities focus on junior and women's shooting activities such as a Junior Sports Shooting Camp in the summer, 4-H Regional and State Shooting Championships, Daisy/Jaycee B.B. Gun Championship teams, Intermediate/Advanced Junior Olympic Shooting Camps, providing travel funds for junior shooters competing in national and international matches, Women On Target events and similar activities. We will be looking to support other shooting groups in the future, such as handicap and senior shooting activities.

The Foundation raises funds, invests them, and makes the income from those investments available for the above shooting programs. The Foundation Board of Directors is an elected non-paid body that voluntarily undertakes and supervises the activities of the Foundation. The Foundation has no paid staff.

The Directors have engaged the Trust Company of Manhattan to oversee the investments of the Foundation and expedite the receipt of bequests, gifts of stocks and bonds, and handle donations of real estate and other property of value.

## **OPPORTUNITIES FOR ESTATE TRUSTEES AND EXECUTORS:**

Often, the sale of rifles, shotguns, handguns, ammunition and sporting equipment is cumbersome in estate sales or other forms of property disposition. The Foundation is in a position to accept firearms, ammunition, spotting scopes, reloading equipment, and other items of sporting equipment. The donated items will be professionally appraised, and a written valuation will be provided to estate trustees or executors for tax purposes.

Donations of single guns or entire collections are welcome. The Foundation will collect donated items and assure that all transfers of ownership are undertaken in conformation with state and federal regulations.
